The Agriculture Extension Department, Government of Khyber Pakhtunkhwa received grant financing from National Disaster Risk Management Fund (NDRMF) under Pakistan Hydromet and Climate Services Project/PHCSP funded by the World Bank. Under the aforesaid grant financing Khyber Pakhtunkhwa Agriculture Extension Department launched a development project titled "Climate Resilience through Horticultural Interventions in Khyber Pakhtunkhwa" and intends to apply part of the proceeds of the grant to payments for "IT Equipment" to be procured under this project.
