The Agriculture Extension Department, Government of Khyber Pakhtunkhwa received grant financing from National Disaster Risk Management Fund (NDRMF) under Pakistan Hydromet and Climate Services Project/PHCSP funded by the World Bank. Under the aforesaid grant financing Khyber Pakhtunkhwa Agriculture Extension Department launched a development project titled “**Climate Resilience through Horticultural Interventions in Khyber Pakhtunkhwa**” and intends to apply part of the proceeds of the grant to payments for “**PROCUREMENT OF OLIVES BUDWOOD**” to be procured under this project. The project development objective is contributed to climate resilience through introduction of olive grafting for efficient utilization of potential arable and cultivable wastelands and to diversify livelihood options for local communities in Khyber Pakhtunkhwa.

**The Khyber Pakhtunkhwa Agriculture Extension Department** now invites eligible supplier for the supply of Olives Budwood as per attached technical specifications and quantities.

1. 3. The quoted rates shall include all applicable taxes. The applicable taxes will be deducted from the bills at source or as per the sales tax invoice provided by the firms, if applicable.
4. **CDR/Bank Guarantee @ 2%** of the tender amount shall be submitted in the name of **Project Director, Climate Resilience through Horticultural Interventions in Khyber Pakhtunkhwa** along with the tenders/quotations.
5. Late Quotations will be rejected.
6. Electronic Quotations shall not be permitted.

  9. Successful offerors will submit **10% performance guarantee** as per rules in the shape of **CDR/Bank Guarantee**.
  10. The quoted rates shall be inclusive of transportation charges for delivery.
  11. At the time the contract is awarded, the purchasers reserve the right to increase or decrease the quantity of goods and related services.
  12. Rates will be applicable up-to **30<sup>th</sup> June 2024**.
1. Quotation(s) should be accompanied by adequate technical documentation complete in all aspects, previous such kind of work orders, company profile and catalogue(s) and other printed material or pertinent information for item quoted, including provision of after sales service facilities in Khyber Pakhtunkhwa Failure to comply the same would constitute sufficient ground for disqualification of your Quotation.
  2. The deadline for receipt of quotation(s) by the Purchaser at the address indicated in Paragraph-3 is **5<sup>th</sup> September, 2023 at 10:00 a.m.** Quotation(s) should be submitted as per the instructions contained in the RFQ. The received quotations will be opened on **same day** at **11:00 a.m.** Late Quotations will not be accepted and to be rejected.
  3. **Prices:**  
The prices should be quoted in Pak Rupees and should be inclusive of all supply charges and admissible taxes prevailing in Sindh and other levies payable by the supplier under the contract till the final/ named place of destination.
  4. **Evaluation and Award of Contract:**  
Offers determined to be substantially responsive to the eligibility Criteria and technical specifications will be evaluated by comparison of their prices, in addition to the eligibility and qualification requirements outlined in the Section-II of Quotation Documents. The award will be made to the firm offering the lowest evaluated price that best meets the required standards/ specifications of technical capabilities along with complying/ providing all the requisite information and documentation.
  5. **Validity of the Offer:**  
Quotation(s) shall be valid till 30<sup>th</sup> June, 2024 from the date for receipt of quotation(s).



## SECTION-II

### Instructions for Preparing Quotations

#### 1. Scope of Procurement:

Invites price quotations for procurement and Supply of Budwood (improved variety of *Olea europaea* L.) as described in the Technical Specifications as mentioned in Section-III. The successful supplier will be expected to complete the delivery of Budwood within due time.

#### 2. Qualification/Eligibility of the Supplier:

To qualify for award of the Contract/Purchase Order, a Supplier shall meet/agree the following minimum qualifying criteria:

- a. Goods/Services shall be supplied strictly according to the specifications given in the specification sheet.
- b. The Quotation/Bids must be submitted according to the RFQ and attached specifications.
- c. Conditional quotations will not be acceptable.
- d. Supplier/Authorized dealer have at least **three (03) years** of experience in supplying of the similar goods/services mentioned herein.
- e. The bidder must be authorized distributor/ supplier/ agent for supplying of offered product.
- f. Taxes will be deducted according to government rules.
- g. Quotation must be typewritten.
- h. Incomplete/conditional and overwritten offers will not be considered.
- j. **The Budwood must be delivered to Forest Divisions i.e., Bajaur, Dir Lower, Haripur, Orakzai, or any other Project area in Khyber Pakhtunkhwa mentioned by the Department.**
- k. CDR/Bank Guarantee @ 2% of the tender amount shall be submitted in the name of Project Director, Climate Resilience through Horticultural Interventions in Khyber Pakhtunkhwa along with the tenders/quotations.
- l. **Documentary proof of adequate average annual turnover of at least three years with minimum cost of PKRs. 10.000 million.**
- m. Successful offerors will submit 10% performance guarantee as per rules in shape of CDR/Bank Guarantee.
- n. The Prices indicated in the Price Schedule shall be delivered duty paid (DDP). The price of other (incidental) services, if any, may be mentioned separately.
- o. The bidder shall provide on a duly attested Judicial/Stamp paper an Affidavit stating that the dealer/supplier has never been blacklisted by any Provincial Government / Federal Government/semi-government, Organizations, Agencies or Autonomous Body or Private Sector anywhere in Pakistan and that no litigation is under way against them (Stamp paper Rs. 100/-).
- j. The bidder shall provide an undertaking on a judicial stamp paper duly attested by the oath commissioner/ Notary Public that the quoted goods (Olive Budwood) are true to type and strictly according to the specifications, specified in this document (Judicial stamp paper Rs. 100/-).
- k. **Authorized dealers/supplier must attach proof/commitment of services in Khyber Pakhtunkhwa Pakistan.**
- l. Bid price should be in Pak Rupees.

- m. **The bidder must submit National and Sales Tax Numbers' Certificates and proof of being in active taxpayers list of both kind of taxes, FSC&RD and KPRA.**
- n. The bidder must have proper Business Location (Shop/Outlet) and telephone facility.
- o. The Bidders are requested to give their best and final prices.
- p. The supply/demand of Olive Budwood may be increased or decreased or altered subject to the availability of funds and other constraints.
- q. This office reserves the right to accept or reject all of the submitted quotations as per World Bank Procurement Regulations for IPF Borrowers, Goods, Works, Non-Consulting and Consulting Services July 2016 Revised November 2017, August 2018, and November 2020.
- r. Organizational profile, relevant experience, past performance, list of clients, references, completion certificates / work orders / supply orders in the relevant field should be provided.
- s. The bidder must provide performance satisfactory certificates/ report from the last supplies made.
- t. The firm shall execute contract / agreement on Rs.100/- stamp paper with the Department to abide by all terms and conditions.
- u. Budwood source Nursery/Orchard ownership/contract affidavit (Judicial stamp paper Rs. 100/-)
- v. The firm will also provide the attested photocopy of CNIC of the owner or authorized person dealing with the Department.
- w. Technical employees and its service, salary, and job agreement record.
- x. Joint venture agreement record.

### 3. Other Terms and Conditions:

- a. Payment will be made as per Contract agreement/Purchase Order within maximum of 30 days from the date of receipt of invoice.
- b. To receive payments, the supplier should be duly registered with GST/KPRA and FBR Tax Authorities
- c. **Warranty: True to Type Olive Budwood**
- d. The rates should be inclusive of delivery of goods as per delivery schedule.

### 6. Price Quotation:

The Contract shall be awarded for the whole and/ or specific supplies and shall be based on the unit and total price for fixed unit rate contract. Prices shall be quoted entirely in Pak Rupees. The Supplier shall fill in the rates and prices for all items and/ or specific category of the Supplies described in the specifications. All duties, prevailing taxes in Khyber Pakhtunkhwa and other levies payable by the supplier under the contract till the final/ named place of destination, shall be included in the rates, prices, and total price quotation submitted by the supplier. The rates and prices quoted by the supplier shall be fixed for the duration of the contract and shall not be subject to any adjustment on any account.

1. The inspection of the delivered Olive budwood will be carried out by the Project Inspection Committee/District Inspection Committee.
2. Committee ensuring the quality and of the delivered budwood as per technical specification noted above.
3. The quality of delivered budwood is to be true to type quality which will be checked, in case of defect, the firm will be responsible for replacement of the unacceptable budwood.
