DESCRIPTION: PROCUREMENT OF ORCHARD PLANTS (PHASE-II)

The Agriculture Extension Department, Government of Khyber Pakhtunkhwa received grant financing from National Disaster Risk Management Fund (NDRMF) under Pakistan Hydromet and Climate Services Project/PHCSP funded by the World Bank. Under the aforesaid grant financing, Khyber Pakhtunkhwa Agriculture Extension Department launched a development project titled "Climate Resilience through Horticultural Interventions in Khyber Pakhtunkhwa" and intends to apply part of the proceeds of the grant to payments for Procurement of Orchard Plants (Phase-II) i.e., Fruit Orchards and Date Orchards" to be procured under project. The Project Development Objectives is to contribute towards climate resilience through the establishment of model orchards throughout the Khyber Pakhtunkhwa province.

The Agriculture Department, Government of Khyber Pakhtunkhwa now invites sealed Quotations from bidders for the procurement of the following local certified Fruit Plants and Date Plants as per the specifications provided in the RFQ documents.

Bidding will be conducted through the World Bank's Procurement Method i.e., Request for Quotations, Procurement Process i.e., Single Stage One Envelop and Market Approach i.e., Limited as specified in the World Bank "Procurement Regulations for IPF Borrowers" July 2016 [Revised November 2017, July 2018, and November 2020].

- b) The quoted rates shall include all applicable taxes. The applicable taxes will be deducted from the bills at source or as per the sales tax invoice provided by the firms, if applicable.

- m) Quotation(s) should be accompanied by adequate technical documentation complete in all aspects, previous similar nature of work orders, company profile and catalogue(s) and other printed material or pertinent information for item quoted, including provision of guarantee to provide true to type fruit plants (on stamp paper) in Khyber Pakhtunkhwa including Merged Districts failure to comply the same would constitute sufficient ground for disqualification of your Quotation.
- n) The supply/demand of the goods/supplies/products etc., may be increased or decreased or altered subject to the availability of funds and other constraints.
- o) Offers must be submitted for 100% required quantities. Supplier must Quote only one offer.
- p) Quotations must be typed by computerized text and shall be submitted on company's letterhead.
- q) Quotations by hand or through courier (hard copy) must be dully signed. The Prices indicated in the Price Schedule shall be delivered duty paid (DDP). The price of other (incidental) services, if any, may be mentioned separately.
- r) The suppliers are requested to give their best and final rates.
- 1. **Prices:** The prices should be quoted in Pak Rupees and should be included of all supply/transportation charges and admissible all taxes prevailing of Khyber Pakhtunkhwa and other levies payable by the supplier under the contract till the final destination.

SECTION-II

Instructions for Preparing Quotations

- 1. Scope of Procurement: Invites price quotations for Procurement of Orchard Plants (Phase-II) i.e., Fruit Orchards and Date Orchards" as described in the Specifications as mentioned in section-III. The successful supplier will be expected to complete the delivery of Procurement of Orchard Plants (Phase-II) i.e., Fruit Orchards and Date Orchards" within due time.
- 2. **Qualification/Eligibility of the Supplier:** To qualify for award of the Contract/Purchase Order, a Supplier shall meet/agree the following minimum qualifying criteria:
 - (1) ¹Financial Capability

The Bidder shall furnish documentary evidence that it meets the following financial requirement(s):

- i. Documentary proof of adequate average annual turnover (from any agriculture product/produce i.e., orchard plants i.e., Fruit Orchards and Date Orchards, bulbs etc." etc. supply) of at least three years with minimum cost as reproduced below per Lot. (Financial Audited Statement or Bank Statement to be provided as evidence of last three years).
 - 1. Fruit plants PKRs. 25.000 million per Lot
 - 2. Date plants PKRs. 10.000 million per Lot
- (2) Experience and Technical Capacity

The Bidder shall furnish documentary evidence to demonstrate that it meets the following experience requirement(s):

- a. Supplier must have at least three (03) years of experience in supplying of the fruit plants or similar goods/services mentioned in the bid document and provide verifiable documentary evidence like Purchase Order/Contracts/Completion Certificate to Government / Semi Government / Donor Funded Project (executed by Government only).
- b. The firms / bidders will provide a stamp paper showing the area / size of the nursery they own minimum 8 acres (own land / leased / rented) duly notarized.
- c. Organizational profile, relevant experience, list of clients, references, / work orders / supply orders in the relevant field should be provided.
- d. The bidder must provide satisfactory performance certificates / report from the last supplies made.
- e. The mandatory documents i.e., NTN, Sales Tax, FSC&RD, last Completion Certificates must be properly flagged.
- f. Active Taxpayer List indicating company's/Firm's Name.
- g. Sample of original fruit plants tags of Federal Seed Certification & Registration (FSC&RD) Department (preference will be given to FSC&RD certified plants).
- h. The firm will also provide the attested photocopy of the CNIC of the owner or authorized person dealing with the department.
- i. The firm shall execute contract / agreement (Judicial stamp paper Rs.100/-) with the Department to abide by all terms and conditions.
- j. The bidder shall submit an affidavit that bidder is not blacklisted by public or private organization/firms must not be debarred by any organization (Judicial stamp paper Rs. 100/-).
- k. Affidavit to provide true to type healthy plants (Judicial stamp Rs. 100/-)
- 1. Nursery ownership affidavit (Judicial stamp paper Rs. 100/-)

In order to receive payments under the contract, the successful bidder must be Income Tax and Sales Tax register and must be on active taxpayer list of FBR. However, this would not disqualify the bidder from participating.

- m. The Bidder must submit an affidavit (Judicial stamp paper Rs. 100/-) that the firm is not engaged in any litigations etc.
- n. Provide details of technical employees and their service, salary, and job agreement record engaged in the nursery production.
- o. In case of Joint venture, JV agreement must be submitted before signing of the contract on the prescribed format (Maximum number of members in the Joint Venture (JV) shall be: 02 (Two)).
- p. Bidder shall provide additional Two (02) photocopies of the tender document along with original binning documents.
- q. All taxes will be deducted according to FBR/Government rules.
- i. Quotation must be type written. Incomplete/conditional and overwritten offers will not be considered.
- k. This office reserves the right to accept or reject all of the bidding documents as per World Bank Procurement Rules & Regulations for IPF Borrowers, Goods, Works, Non-Consulting and Consulting Services July 2016 Revised November 2017, August 2018 and November, 2020.

- 6. **Price Quotation**: The Contract shall be awarded for the whole and/ or specific supplies and shall be based on the unit and total price for fixed unit rate contract. Prices shall be quoted entirely in Pak Rupees. The Supplier should quote the rates for all fruits/dates plants (Lot wise) and/ or specific category of the Supplies described in the specifications. All duties, prevailing taxes in Khyber Pakhtunkhwa and other levies payable by the supplier under the contract till the completion / place of destination must be included in the total price quotation submitted by the supplier. The rates and prices quoted by the supplier shall be fixed for the duration of the contract and shall not be subjected to any adjustment on any account.





SECTION III - SPECIFICATIONS

1. Technical Proposal

2- Payment Criteria

Payment will be made as per Contract agreement/Purchase Order.

The method and conditions of payment to be made to the Supplier in PKR under this Contract shall be

- Satisfactory delivery certificate from concerned District Director Agriculture (Extension).
- Invoices.
- Delivery Challans.
- All applicable taxes will be deducted at source.
- Hundred (100) percent payment against the supplies delivered, received, and accepted, shall be made within Sixty (60) days of submission of claim supported by a copy of the General Sales Tax (GST) invoice showing the amount of sales tax have been submitted along with the invoice. Incase GST is not applicable on the Goods to be procured, the supplier shall provide the documentary evidence to the said effect.

3- Delivery time

- The delivery as per Schedule provided below in Section III -5.
- In case of late delivery, the contractor should pay 5% or PKRs. 25,000/- (whichever is higher) of the cost of the remaining supply. The delay beyond 10 days would entrust the right of cancellation of the agreement with the costs to be borne by the supplier.
- The maximum amount of liquidity damages shall be 15% of the contract value.

- 3. The quality of delivered plants shall be true to type quality, disease, and insect pest free, which will be checked in case of defect the firm will be responsible for replacement of the unacceptable plants in stipulated time.
