Director General Agriculture Extension Khyber Pakhtunkhwa Peshawar invites sealed bids based on Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules, 2014 from reputed sale tax registered firms on single stage two envelope basis for the **supply/installation of Security Cameras System; Desktop Computers; Printers; Laptops; UPS; Bar Code Readers; Split AC 1.5 tonne (Hot & Cool); Photocopier; Different Electronics Equipments; Lab Equipments and Chemicals for Soil Testing; Bar Coded Envelops for Soil Sampling (Auto Sealed & One Kg)** etc. (detail available in SBD) under different ADP/PSDP Projects for financial year 2021-22.

Bids should be addressed to the Director General Agriculture Extension Khyber Pakhtunkhwa Peshawar. The following terms and conditions shall apply:

- i. The bid solicitation documents containing the subject items may be obtained from the office of undersigned in person from 10:00 AM to 05:00 PM on any working day or from the date of uploading of this bidding notice on KPPRA website till one day prior to the deadline for submission of bids @ Rs. 1000/- (Non-refundable).
- ii. The interested firms fulfilling the required conditions may send their quotations along with 2% of the quoted price indicated against each item in shape of **Call Deposit/Bank Draft** in favour of **Director General Agriculture Extension Khyber Pakhtunkhwa Peshawar** in sealed envelopes latest by 12:00 PM, 15th day of March 2022 along with their bids through registered post (no by-hand will be received) and will be opened on the same day at 2:30 PM in the office of the Director General Agriculture Extension Khyber Pakhtunkhwa Peshawar, in the presence of bidders by themselves or their representatives who may like to attend.
- iii. Only registered suppliers, who are enrolled as Active Taxpayers Lists (ATL); registered with KPRA and FBR are eligible to supply goods/ services to the government department.
- iv. The successful bidders shall be required to supply/install the items within a month after the issuance of supply order. Failure in supply/install of the items within the stipulated period shall entail forfeiture of the earnest money.
- v. Taxes and other due deductions will be deducted as per rules.
- vi. The competent authority reserves the right to accept or reject all bids or quantity or part thereof, under KPPRA rules assigning cogent reasons.
